- d. He will leave Dhaka for Thailand on 28 June, 2016 or on a nearer date and will leave Thailand for Dhaka on 02 July, 2016 or on a nearer date.
- e. He will not be allowed to stay abroad more than the approved period.
- f. He has to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days after his arrival in the country.


