 - c. Organizing authority will bear all the expenses of the participations.
 - d. They will leave Dhaka for Thailand on 05 November, 2016 or on a nearer date and will leave Thailand for Dhaka on 12 November, 2016 or on a nearer date.
 - e. They will not be allowed to stay abroad more than the approved period.
 - f. They have to submit a report to the Ministry of Disaster Management and Relief within 15 (Fifteen) days of return in the country.
- g. This order is issued with approval of the competent authority.


