Ministry of Disaster Management & Relief, Bangladesh, Mr. Md Shah Kamal, Secretary. Ministry of Disaster Management & Relief, and Mr. Md Reaz Ahmed, Additional Secretary & Director General, DDM, MoDMR will go to Kolkata on 6th November 2016 to visit Disaster Management Centre and Urban Management Centre of Administrative Training Institute of Kolkata and will meet the respective authorities.
- 3. Mrs. Parveen Chowdhury, wife of hon'ble minister will accompany him and she will bear all the expenses. Mrs. Nadira Begum, wife of P.S. to minister will accompany him and she will bear all the expenses. Mrs. Ranjana Roy, wife of Ardhendu Shekhar Roy will accompany him and she will bear all the expenses.
- 4. The terms and conditions are as follows:
 - a. While participating the conference and on journey to & from, they will be treated as on duty.
 - b. They will draw their pay and allowances in local currency, no part of it shall be drawn in foreign currency.
 - c. The travel and other costs of hon'ble minister will be borne by the host country.
 - d. Delegation members of civil society and academia will bear their own expenses.
 - e. All expenses of the participants in connection with this conference will be borne by the sponsoring Organization/Agency/Project (shown beside of their names). If the organizer does not bear the expenses of Secretary/Additional Secretary/ equivalent government officials according to their entitlement, rest of the expenses will be borne by Government of Bangladesh as per existing rules.
 - f. Delegation will leave Dhaka for India on 1 November, 2016 or on a nearer date and other than Kolkata team the rest of the delegation will leave India for Dhaka on 6 November, 2016 or on a nearer date. The Kolkata team led by hon'ble minister will leave Kolkata on 9 November or on a nearer date.
 - g. Mr. Ardhendu Shekhar Roy. Joint Secretary, MoDMR will leave Dhaka on 31st October, 2016. Because he will attend a workshop on eco-system based DRR prior to AMCDRR to be held on 1-2 November 2016. He will also participate AMCDRR. After completion of AMCDRR he will enjoy ex-Bangladesh leave.
 - h. During the visit of Kolkata, the expenses of Hon'ble minister will be borne by the Government of Bangladesh, The expenses of Mr. Md Shah Kamal, Secretary, Ministry of Disaster Management & Relief, and Mr. Md Reaz Ahmed, Additional Secretary & Director General, DDM, MoDMR will be borne by JICA.
 - i. Each participant has to submit a report within 15 (Fifteen) on return.
